Dear Oksana Mikhailovna,

I, Yelena Mashonskaya, am the representative of Nikolas Cheropoulos, a Swedish citizen and the father of two girls who are studying at your kindergarten, Anthoula Anthie Cheropoulou, born on June 08, 2012, and Alexandra Cheropoulou, born on April 01, 2015.

More than a month ago, on April 1 and 2, 2019, Nikolas Cheropoulos, his translator and I, as his official representative, visited the State Educational Establishment "Sanatorium Kindergarten No. 480" in order to have a conversation with the teacher-psychologist of this establishment Olga Anatolyevna Adrianova.

Both conversations took place in your office in your presence.

At the request of the psychologist, Nikolas Cheropoulos provided the letter with a written request to conduct an examination of his daughters in the form of conversations, games and other acceptable ways, indicating that he is extremely concerned about the psychological state of his daughters, which he observed during the last meeting. Nikolas Cheropoulos gave this written request during the visit on April 2, 2019 in the presence of all the persons mentioned above.

According to the legislation on appeals of citizens and legal entities, the teacher-psychologist, as an employee of a public institution, is obliged to give an official response within a period not exceeding 15 calendar days. If the appeal requires verification or additional research within its framework, then the period is extended to 30 calendar days.

Based on the information received from Nikolas Cheropoulos, he still has not received an official answer to his appeal regarding the examination of the psychological state of his daughters.

On May 2, 2019 (a month later), he received an unsigned document by e-mail, without a date and a seal, stating that the examination would not be conducted. From the point of the law, such a response is not official or acceptable.

In connection with the non-receipt of the official response and violation of the deadlines established by the legislation, we ask you again to consider the appeal of Nikolas Cheropoulos and instruct the teacher-psychologist to conduct an examination of Anthoula Anthie

Cheropoulou, born on June 08, 2012, and Alexandra Cheropoulou, born on April 01, 2015, who are the pupils of your kindergarten.

We ask you again to provide Nikolas Cheropoulos with the results of the examination in writing by sending them as an official email to: [nicolas.cheropoulos@ginail.com](mailto:nicolas.cheropoulos@ginail.com)., as well as to the address of Arzinger Attorneys-at-Law indicated in the header of the letter.
